- 250UC Gantry Beams on a 2.5m (8.2 ft) grid which carry a safe working load of 700 kg (1543.24 lbs) per linear metre
- 32Amp and 50Amp 3 phase, (415 volt) socket outlets throughout
- 10 Amp single phase (240Volt) socket outlets throughout
- Low velocity air conditioning (design background noise level in studios = 20+3db)
- 400 Amp powerlock
- Flexible and integrated space that can accommodate Virtual Production set-ups
